In 2018 the Ministry of finance has issued the Lao Financial Reporting Standards and allows companies to enjoy a transition ending 1<sup>st</sup> January 2021 where Lao FRS becomes mandatory for large entities as well as small and medium enterprises. Therefore, the Chief financial officers, accounting manager and accountants will have to tremendous 2020 in preparing the transition of their organization to Lao FRS.
