



Press Corner

Singapore will begin trialing the import of renewable hydropower from Laos



Keppel Electric, a subsidiary of Keppel Infrastructure Holdings and EDL aim to jointly explore opportunities to import renewable energy into Singapore through this partnership which EDL will export while Keppel will import up to 100MW of renewable hydropower from Laos to Singapore via Thailand and Malaysia using existing interconnectors. Dr. Tan See Leng, Second Minister for Trade and Industry, noted that he is heartened to see ASEAN member states continue to take active steps together to accelerate the region's energy transition efforts towards a more sustainable energy future for all.

The trial electricity supply is expected to begin once all technical, commercial, legal and regulatory arrangements are confirmed with the governments of the four ASEAN member countries and following the execution of a binding power purchase agreement between Keppel Electric and EDL which expected to be in 2022.


Finance ministry trials 11 companies in customs scheme



Finance ministry trials 11 companies in customs scheme, which means they will no longer need a certificate of privilege from the Customs Department regarding taxes for the next six months. The companies in question are our Silver Sponsors Lao Ford City, Coca-Cola Laos, our Members Unilever Laos, and Beerlao, Souvanny Home Centre Public Company, Honda New Chip Xeng Co., Ltd., Express Food Group Lao Co., Ltd., Lao Mobile Group Co., Ltd., TIPCO Asphalt Lao Co., Ltd., Toyota Laos Co., Ltd., and CI Trading Import-Export Sole Co., Ltd. Companies who are members of the Authorised Economic Operator

(AEO) programme will be given special rights with regard to trading and the import and export of goods under AEO standards, to ensure trade safety and strict compliance with laws and regulations in line with international standards.

China-ASEAN Expo opens, Laos calls for greater connectivity



The 18th China-ASEAN Expo and China-ASEAN Business and Investment Summit opened on September 10 in Nanning, the capital of south China's Guangxi Zhuang Autonomous Region, pushing for the building of a China-ASEAN shared future. This year's expo, under the theme "Sharing opportunities created by the new land-sea corridor, building the China-ASEAN community with a shared future" which aims to deepen cooperation in trade, economy and other fields between China and ASEAN and consolidate the high-level dialogue platform. Prime Minister Phankham Viphavanh said that the Expo

has been an important platform to promote ASEAN-China cooperation in recent years. He also added that ASEAN needs China's technical and financial assistance to support its connectivity effort as the 10-member regional bloc is forging greater connectivity within the ASEAN region as well as other regions.

Business Enviroment & News

Law on Customs

The latest law on customs No. 81/NA provides the principles, procedures and measures related to the management of the import-export, transit and movement of goods, means of transport and passengers through customs border checkpoints to facilitate trade, promote investment and international integration and connectivity with an aim to strengthening the Customs Administration, ensuring revenue collection in a complete and timely manner, protecting the interests of operators, security and social stability of the State and contributing to the social and economic development of the State.

The law applies to natural, legal persons or organizations engaged in the import-export, transit, movement, storage of goods, entry-exit of means of transport and passengers through customs border checkpoints or other related customs operations in Lao PDR. Rights of every citizen to monitor, provide information, report and cooperate with the customs officers were also added in the law.

Customs facilitation operates by establishing mechanisms and providing facilities such as information platforms, modern tools, knowledgeable personnel as well as the ability to provide services in accordance with international standards and the laws. Prioritizes the facilitation of customs for AEOs, domestic and foreign investors who intend to relocate production bases into Lao PDR.

Customs clearance shall be undertaken with cargo declaration and detailed customs declaration which can be made electronically or manually at a customs border checkpoint or at a place designated by the Customs Administration.

The customs declarant shall be responsible for the information of the declared goods or non-commercial goods on the customs declaration form including all supporting documents as following:

- 1. Cargo declaration form and transport documents;
- 2. Detailed customs declaration form;
- Commercial Invoice;
- Packing list;

Supporting documents for the preferential tariff treatment shall consist of the following:

- 1. Certificate of origin for preferential tariff treatment; and/or
- 2. Import-export certificates and/or permits in the case of restricted goods.

Detailed Customs Declaration can be lodged the customs declaration prior to the arrival of goods at the customs border checkpoint as follows:

- 1. The customs declarant can make an advance declaration within seven working days and shall provide all related documents as stipulated in Article 27 of this law. The cargo declarations or transport documents shall be submitted to customs officers after the arrival of goods;
- 2. After a detailed customs declaration is registered, the customs declarant shall settle the customs duties after the arrival of the goods at the customs border checkpoint;
- 3. After the arrival of goods at the customs border checkpoint, the customs officer shall conduct a physical inspection or apply a risk management approach in accordance with the regulations.

The exchange rates used for the calculation of customs duties are the exchange rates between the currency of Lao PDR and foreign currencies announced by the Bank of the Lao PDR at the time the customs declaration is lodged.
