Message From President of ECCIL

BORDERS OPENED!

Dear Members.

The 2nd Quarter of 2022 hopefully marked the beginning of the post-covid era. Covid seems to have given up, the borders with Vietnam and Thailand opened and cross-border trade can now start to pick up.

The Quarter also saw the Chamber slowly but surely move towards Re-Connecting the members and the Lao-Europe business society. A real kick-off was the Annual ECCIL Meeting in combination with the 1st Lao-Europe Business Networking and Promotion Event at Crowne Plaza on May the 23rd, the latter co-organised with the European Union in Laos.



The event was attended by H.E. Dr. Sinava Souphannouvong, Deputy Minister of Energy and Mines, several representatives from the Ministry of Industry and Commerce, the Ministry of Public Works and Transport and from the Lao National Chamber of Commerce and Industry.


Guests and visitors saw exhibition booths from members of the Chamber showcasing their businesses, services, and products, and were later introduced to the Chamber's and Team Europe's work in supporting trade, Investment, and private sector development in Lao PDR. The presentations were made our Executive Director Thiane Khamvongsa and European Union Head of Cooperation, Vincent Vire.

We are now working on bringing networking and business promotion back to a pre-Covid level within the rest of this year.

The joy of seeing Covid disappearing and borders opening and a brighter outlook for Lao business was however quickly dampened by increasing fuel prices and new government regulation on cross-border transport of goods. Both events are increasing costs for business operators that are already struggling to compete with our neighbours' FOB costs.

The fuel crisis resulted from the rising global oil prices, a side effect of the Russia-Ukraine war. It has been worsened by the depreciation of the Lao KIP, which has dropped sharply to the USD pushing up the price of fuel imports further. The impacts of the new government regulations and how these should be presented to the government is being discussed between the different chambers in Laos.

We are already quickly mowing into the European summer holiday season with many of our members surely taking the opportunity of opened borders to go back to Europe for visiting friends and family for the first time in a couple of years. To all those I wish safe traveling and to everyone I wish a nice summer!

Sheng Lee, Country Head of ANZ Bank Laos said "At this junction, the biggest challenges in the financial industry is attributed to external risks such as the continued depreciation of the Kip (which exacerbates inflationary pressure) and liquidity shortfalls attributed to a mismatch of foreign exchange inflows with the actual needs of importers. The impact is profound and has an immediate and significant impact on businesses and consumers. This challenge is anticipated to continue (at least in the short to medium term) and will prevail to be a significant test for most businesses operating in Laos".

As a financial institution, ANZ is continually monitor these risks and proactively work with our regulator, customers and external stakeholders to discuss the challenges and potential solutions.

The main purpose of the lastest survey rolled out on 27 June was to hear how our

members have experienced the current economic situation and how it may impact their business. Gathering this information from ourmembers every quarter is key to recognize trends over time and will be used to strengthen the advocacy efforts by the Chambers to the Government of Lao PDR.

Addressing Inflation Among Top Priorities for Central Bank



The Bank of the Lao PDR (BOL) will take action to address spiralling inflation as one of its top priorities for the remaining six months of this year. This was one of the key messages delivered by the BOL Governor, Mr Sonexay Sitphaxay, in his report on the first day of the current National Assembly session. In his report, Mr Sonexay said "Laos is experiencing skyrocketing inflation, like many other countries, due to internal and external factors. But we have several measures and plans that will be put into practice to tackle this problem." His report stated that inflation increased significantly over

the first five months of this year, with a record 9 percent increase. The inflation rate in May stood at 12.8 percent, which was 4 percent higher than the figure endorsed by the National Assembly. The central bank, on behalf of the government, asked Assembly members to reconsider the recently approved target of 5 percent inflation in view of the current situation. The BOL will also address several other issues, including the disparity in currency exchange rates offered by banks and exchange units on the streets, as well as initiating fiscal policies to tackle economic turbulence.

Cryptocurrency Trade Adds Millions of Dollars to State Budget



Several million dollars have been generated from the trade in cryptocurrency after the government authorised 13 companies to operate a digital currency business, the government told the National Assembly (NA). Eleven of the 13 companies have carried out transactions in digital currency. Ten of the companies have handed over US\$4.5 million (more than 66 billion kip) and 5.71 billion kip to the government in copyright fees in return for permission to operate the business. In addition, Wap Data Technology Laos - the company that carries out cryptocurrency excavation and

mining-handed over the first tranche of profit tax and value-added tax for 2022, amounting to US\$6.50 million (more than 82.3 billion kip) for the state. The cryptocurrency business is a new source of revenue that has made an important contribution to the state budget. Over the first five months of this year, more than 10,633 billion kip in revenue was collected, which represents 33.66 percent of the budget plan for this year plan. The revenue collected represents an increase of 23.7 percent compared to the same period last year.

Special economic zone authority to issue certificates of origin



The Department of Import and Export under the Ministry of Industry and Commerce recently assigned the authorisation to the Vientiane Special Economic Zone Authority Office for issuing the preferential certificates of origin. According to the Lao Trade Portal under the management of the ministry, the office can now issue preferential certificates of origin to companies and factories operating within the Vientiane Special Economic Zone. The measure will benefit both existing business entities and incoming investors. The increased restrictions for monitoring and inspecting foreign transport vehicles entering Laos PDR.

The notification from the Ministry of Public Works and Transport Cabinet Office No.04718/PWT, dated 23 February 2022, introducing increased restrictions for monitoring and inspecting foreign transport vehicles entering Laos PDR - to ensure transport operation aligning with the laws and regulations and transports among countries and to extend the Notification of the Primeter's

Office No. 63/PMO, dated 17 January 2022, this is to notify to all relevant organizations in order to anticipate strictly in implementing all prohibitions, monitoring, inspection and penalty of the foreign vehicles such as:

- Prohibiting vehicles and trucks which carry empty containers to enter the international checkpoints in the 1. Laos PDR to transfer goods (Except for the allowed vehicles and trucks that contain goods that are not able to transfer or special goods such as dangerous goods, larges oversized goods, but each case must be permitted from the Department of Transport, allow empty vehicles and trucks carry empty containers to the transfer goods at the border checkpoints, land posts, warehouses and permitted places).
- For the vehicles and trucks which are permitted temporarily to enter Laos within the permitted areas, of which are not allowed to get around from the permitted as stated in the contracts among the countries as the Lao PDR is the member.
- Prohibiting foreign vehicles which are permitted to enter Laos temporarily to transfer goods outside the permitted border checkpoints, land posts and areas. After transporting goods all vehicles must return to home countries. Prohibiting all vehicles to transport goods in the Lao PDR.
- Monitoring, inspecting and penalising vehicles that are remade of technical conditions, overloaded goods are permitted and foreign drivers who drive Lao vehicles without work permits in the Lao PDR.

Moreover, pursuant to the Decree on the Land Checkpoint No. 513/GOL, dated 04 August 2021, the Article 18 mentions that areas where the service of land posts: goods vehicles and containers which transport in-out and pass through the border checkpoints of the Lao PDR where land posts operating must enter those checkpoints. For Vientiane Capital, all foreign goods vehicles are not permitted to pass through the International Friendship Bridge Checkpoint 1 strictly and implement the Notification of the Ministry of Public Works and Transport No.242/PWT, dated 23 April 2021 strictly.

At the same time, Department of Public Works and Transport in all provinces and Vientiane Capital collaborate with all relevant organizations summarize and report the implementation of this Notification to the Department of Transport, the Ministry of Public Works and Transport monthly in order to consolidate summaries and report to high levels.

The new rule prohibits foreign vehicles and trucks which carry empty containers to enter the international checkpoint in Lao PDR to transfer goods - has been raising the concerns on the increasing the time and costs of cross-border trade. The joint chambers are taking this as a advocacy issues to their members who has been effecting by this new Notification, and we are working on offering a solution to the Ministry of Public Works and Transport that meets the objectives of all parties whilst ensuring the cost of completing the border process is not increased.

Business Environment & News



The Amendment of the Law on Enterprise (Version – 2013)

From April to May 2022, Department of Enterprise Registration and Management of the Ministry of Industry and Commerce (MoIC) organized the Public Consultations on the Draft Amendments to the Law on Enterprise (Version 2013) nationwide 4 times: northern part, central part, southern part and the central level in Vientiane Capital.

This is one of the main activities of the Pillar A in the Lao Competitiveness and Trade Project (LCT). The comments from the participants of the public consultation meetings of the Law on Enterprise nationwide are summarized below:

- To redefine general provision of the Enterprise Law in the Part I in alignment with the structure of other laws.
- Article 13 Conversion of Forms and Kinds of Enterprises: agreed on the conversion from an individual enter prise to a company without dissolution and to make new regulations under the law as the reference for the implementation:
- Article 14 Enterprise Registration and Article 21 (New) Business Operation after Enterprise Registration: agreed that enterprise is required to register prior to the commencement of the business operation in accordance to the law on enterprise, the registered enterprise shall apply for the investment license and/or the business operation license from the relevant authorities.
- Article 17 (New) Enterprise Registration Certificate: agreed to contain objectives of business operation in the back of Enterprise Registration Certificate, and to identify the type of enterprise that need approval from the relevant authorities prior to the business operation,
- Article 207(New) Enterprise Registration Officer: to identify rights and obligations as same as the rights and obligations of the Industry and Commerce Sectors, and to elaborate the regualtions under the law as the reference for the implementation.
- Part IX Management and Inspection of Enterprise: proposed to separate into 2 sectors: Sector 1 Enterprise Management, and Sector 2 Enterprise Inspection, in alignment to the structure of other laws.
- Part X Awards and Sanctions: proposed to define the general provision in the law. For the special sanctions such as fine shall be defined in the regulations under the law which can be revised in accordance with the socio-economic during each period.

The amendment of the Law on Enterprise is the response to the Prime Minister's Order on Improvement of Regulation and Coordination Mechanism on Doing Business in Lao PDR, No. 02/PMO, dated 01 February 2018. The revision has taken into consideration two key indicators including: Indicator No.1-Starting a Business, and Indicator No.6-Minority Investor Protection.

The amendment committee has organized technical consultation on the amendment of the draft Law on Enterprise with the line-ministries including Department of Investment Promotion (Ministry of Planning and Investment), Lao Securities Commission Office (Bank of the Lao PDR), Tax Department (Ministry of Finance), and under the supervision of the National and International Legal Experts. The draft amendment of Law on Enterprise is scheduled for the revision and approval by the Government monthly meeting in July and the endorsement at the 4th Ordinary Session of the National Assembly's Ninth Legislature in late 2022.
