On our journey to become a financially self-sustainable organization, we reflected, we changed, we adapted and readjusted our courses and thanks to that flexibility, 2022 has been a successful year on many fronts. Last year was the year where restriction due to the COVID-19 pandemic eventually lifted and we could go back to enjoy these things we were deprived for 3 years and could plan and work hard again for meaningful events. At the risk of contradicting one of the greatest qualities in business –humility –I'd like to share a selection of those successes with you here:



- In 2022, following our mandate to invest in capacity building for our members, we delivered 15 trainings to more than 352 participants.
- We organized 5 networking events, gathering over 303 participants from the leading European businesses in the country.
- -We organized 7 seminars, forums, and talk gathering over 345 participants on topic such as Sustainable Economic Development, E-commerce, Biotrade products, intellectual property in Lao PDR or Export to the EU.
- We celebrated the 10th anniversary of ECCIL in style, delivering our first Charity Gala, which raised over 10,000 USD for the Lao Friends Hospital for Children.
- We organized several events promoting green economy and sustainable ways of doing business such as the Environmental impact and Sustainable Economic Development forum, the responsible Business Conduct Forum, the Corporate Social Responsibility Award, and the Best Employee and Best costumer Experience Award.
- We successfully launched Glue Up for our members to manage membership subscription, registration for events and company profiles more effectively

Health, Environmental Impact, and Sustainable Economic Development Nexus in the Mekong Region and Debate on Air Pollution and its Solutions in Lao PDR.

On November 10th and 11th 2022, a series of events on sustainable development were organised by the French Research Institute for Sustainable Development in Laos (Dr. Karine Peyronnie, Dr Xavier Mari and Dr Eric Deharo, senior researchers), in collaboration with the Research Institute for Science and Innovation of the Ministry of Education and Sports (Dr Oudomphone Insisiengmay), the European Chamber of Commerce and Industry in Lao PDR (ECCIL EURO Cham) and the Agence Universitaire de la Francophonie (AUF).

The event aimed to raise awareness on the issues of air pollution and to help develop education through mediation and scientific argumentation in the search for solutions. The objective was to illustrate through different activities, the work in progress, to understand, monitor, and develop technologies and approaches to overcome this major challenge, which is growing in Lao PDR.

Funded by the French Ministry of Europe and foreign Affairs through a solidarity fund for innovative projects (FSPI), the project « One Health in practice in South-East Asia (OHSEA) » is piloted by the French Institutions such as the Research Institute for Sustainable Development (IRD), the International Cooperation Centre in Agronomy Research and Development (CIRAD) and the national Centre of Scientific Research (CNRS).



Its goal is the understanding of the mechanisms of emergent or re-emergent diseases, in order to prevent them. OHSEA aims to promote a multidisciplinary approach of health concerns by highlighting the close links between health. animal human health and global ecology.

IRD entrusted the management of Component 1 of this project to the Agence Universitaire de la Francophonie (AUF)-Asia-Pacific. Under this component, 11 projects have been selected and are monitored by AUF in 3 countries: 4 projects in Cambodia; 4 in Laos and 3 in Vietnam.



The Environmental impact and Sustainable Economic Development forum and the Debate on Air Pollution and its Solutions in Lao PDR were opened by H.E Assoc. Prof. Dr. Phouth Simmalayong - Minister of Education and Sports, H.E Madame Siv-Leng Chhuor - Ambassador of France and Dr Valérie Verdier - President Director General of the French Research Institute for Sustainable Development (IRD).



The events welcomed more than 200 participants of the business community and students and featured a wide range of researchers, scientists. EuroCham's leaders. business members. academics, from Lao PDR, Cambodia and Vietnam as speakers, panellists, moderators and participants including the World Bank, EU, the Natural Resources and Environment Research Institute of the Ministry of National Resources and Environment (MoNRE), Swiss Contact, FAO. Wildlife Conservation Society. Centre for Natural Resources and Environment of Cambodia Development Resource Institute (CDRI), National University of Laos (teachers Faculty of Natural Sciences, Faculty of Economics and Business Management and Faculty of Social Sciences),

Faculty of Architecture, Faculty of Engineering, Faculty of Environmental Sciences, Faculty of Natural Sciences, Faculty of Economics and Business Management and Faculty of Social Sciences), UNIDO, Zero Waste Laos, SilviCarbon, Burapha, Coca-Cola, Eurocham Vietnam, who contributed their experience, research. insights end best practices in their respective domain of expertise.



The Environmental impact and Sustainable Economic Development forum, presented by Thiane Khamvongsa, Executive Director of the European Chamber of Commerce and Industry in Lao PDR, consisted in 4 panel discussions on various themes related to economic development and pollution in the region, as part of ECCIL EuroCham's mission to encourage the business community to recognize the importance of creating harmony and balance between economic development and environmental sustainability and of integrating environmental considerations into the economic development planning process.

The Debate on Air Pollution and its Solutions in Lao PDR ended with the exhibition "Black Carbon: the dark side of human activity" on air pollution in the ASEAN region developed in the framework of an International Research Network (IRN SOOT SEA: Impact of Black Carbon in South East Asia) and led by Dr. Xavier Mari, with the contribution of Dr Olivier Evrard, senior researchers at IRD. The exhibition is an overview of what is known about anthropogenic air pollution by fine particles. It presents the health, climate, environmental and socio-political issues linked to this pollution for Southeast Asia as a whole.

BRUSSELS, Belgium - 13 December 2022. The Executive Director of the European Chamber of Commerce and Industry in Lao PDR, Thiane Khamvongsa, attended the 10th ASEAN-EU Business Summit organized by the EU-ASEAN Business Council. Key business and political leaders from both regions attended and spoke at the Business Summit.

Starting with the welcoming remarks from Mr. Martin Hayes, EU-ABC's Chairman to all representatives, "We celebrate 45 years of EU - ASEAN (ties) but need to foster even further relations. We need investment for the long term. ASEAN is one of the few bright spots globally for investment. At the Council (EU-ABC), we want to boost relations and deepen the alignment that the EU and ASEAN already have on a great number of topics. We want to ensure a better, more just, sustainable future."

Following the official keynote address by three delegates, H.E Charles Michel, President of the European Council mentioned the five areas to be focused on for the EU-ASEAN cooperation, (1) Connectivity, (2) Climate change, (3) Digital cooperation, (4) Infrastructure, and (5) Social security.

He further expressed that trade is a powerful tool for promoting closer ties and boosting the common trade between both regions through partnership and cooperation agreements.



H.E. Pham Minh Chinh. Prime Minister of the Socialist Republic of called Vietnam. has on the EU to remove the "yellow card" on Vietnamese fisheries and soon ratify the EU-Vietnamese Investment Protection Agency

(EVIPA). He also called for the EU's maximum support in finance and technology and further emphasized that global issues need global approaches, and reiterated Vietnam's strong commitments to climate change, and green, sustainable development.

"The global economy is currently in a bad shape as it is plagued by multidimensional issues. In the face of challenges, the Southeast Asia region remains quite stable. Indonesia, as ASEAN chair next year, will address three priorities. One is to expand regional growth through connected and harmonized markets. Second is to accelerate the digital economy in ASEAN and third is to strengthen the resilience of ASEAN economies." Said H.E. Airlangga Hartarto, Co-ordinating Minister of Economic Affairs, on behalf of President Joko Widodo of the Republic of Indonesia in his opening keynote address.



ASEAN's sustainability goals, supply chain, and boosting trade were the main topics to be discussed during the two-panel discussions between the EU-ASEAN government and business leaders. The first-panel discussion was "Reinvigorating the EU's interest in ASEAN: Trade, Investment, and the Digital Economy". The panelists discussed underlining the rekindled interest the EU has in SEAN in terms of sustainable development in addition to trade, investment, and the ongoing difficulties in this partnership. though. The absence of a uniform regulatory framework, the glacial progress of digital trade financing, and supply chain transparency are part of the biggest concerns for the European companies operating in ASEAN nations.

The second-panel discussion was on balancing the sustainability goals and trade boosting in both regions. Therefore, sustainable development was suggested to be a part of trade agreements. The hospitality industry is gradually recovering from COVID-19 in many countries in ASEAN, it is also significant for them to promote sustainability through traveling.

H.E. Ferdinand Marcos Jr, Philippine President delivered his closing speech appreciating the EU-ASEAN Business Council for its assistance as ASEAN member-states dealt with difficilties including supply and high pricing issues during the COVID-19 recovery.

By providing relevant records and data about these life events, e-CRVS will support the effective delivery of essential services and help assess the goals of the government's social and economic development plan.

# **ECCIL At Work**

12-14 Dec

Bi-annual meeting of the European Business Organization Worldwide Network.



From December 12 to the 14th, 2022, the European Business Organization Worldwide Network (EBO WWN) held its bi-annual meeting attended by Executive Directors and representatives of member European Chambers from close to 40 countries outside of the EU in Brussels. Executive Director **Thiane Khamvongsa** participated to the series of meetings as a representative from ECCIL EuroCham Laos.



The EBO Worldwide Network is the only organization that represents European business interests in markets outside the European Union and forms an active network in more than 47 key markets that serves European Businesses. The European chambers of commerce and European business associations within the EBO Global Network work daily with European Union delegations around the world with the shared interest of supporting European companies.

The meetings provided members the unique opportunity to meet colleagues from the various European Chambers worldwide as well as listen and engage directly with officials from the EU and European business associations, particularly in areas of potential cooperation in future. The bi-annual meeting aimed to strengthen cooperation, exchange ideas, good practices and experience with other Executive Directors from other European Business Organization worldwide outside of Europe, and to provide the network new insights and as well as a platform for enhanced collaboration, building partnerships and share valuable experience and expertise.



During the first part of the meetings, the EBO's representatives met several European commission's Directorate General during the week. This includes the Directorate General for Internal Market, Industry, Entrepreneurship and SMEs that works for an open, seamless and resilient Single Market, with open borders and free flow of goods and services. The different commissions reminded the EBO's of priorities of the EU commission: collaboration without creating dependency, accompanying the green transition and cooperation with private sector within the framework of Team Europe, and encourage the EBO's to solicit support and partnership through identifying projects common projects.

Presentations by the Green & Circular Economy department from DG GROW were made to the EBO's on EU's projects of clusters in the local, regional, and national level and work on strengthening the industrial ecosystem of regions with a focus on Matchmaking Events and encouraged EBO's to team up with other cluster organizations from Europe and third countries and find new collaboration opportunities at dedicated matchmaking events.

The EBO's also met with the DG International Partnerships, European Commission, responsible for formulating the EU's international partnership and development policy, with the goal to reduce poverty, ensure sustainable development, and promote democracy, human rights, and the rule of law across the world. The DG informed the EBO's of their mission to contribute to sustainable development, to eradicate poverty, and promote peace and the protection of human rights through international partnerships that uphold and promote European values and interests.



A meeting was also held with Business Europe, the leading advocate for growth and competitiveness at the European level, standing up for companies across the continent and campaigning on the issues that most influence their performance. A recognized social partner, Business Europe speaks for all-sized enterprises in 35 European countries whose national business federations are our direct members and is headquartered in Brussels at the heart of the EU institutions.

They work on behalf of their members to ensure that the voice of business is heard in European policymaking and interact regularly with the European Parliament, Commission and Council as well as other stakeholders in the policy community.



# **ECCIL At Work**

During the 2nd part of the meetings, the EBO focused on their own clusters with each region holding a coordination meeting, and with sharing sessions between EBO's, namely a Best Practice Workshop on Advocacy and Financial Sustainability.

The EBOWWN ASEAN cluster also met with the EU ASEAN Business Council represented by ED Chris Humphrey, who were in Brussel for the EU ASEAN Summit. All ASEAN EuroCham are members of EU-ABC. EU-ABC counts 50 members and 9 chamber.

ASEAN EBO's and EU-ABC discussed how both organizations could better communicate and identify areas of cooperation and voted to implement regular Zoom meeting with all ED's to collaborate on events like ASEAN-EU business summit and work on aligning the timing and agenda, collaboration with relevant EBO for EU-ABC Business missions with shared plans for upcoming publications, missions, events, flagship event.

Eventually on the last day of meeting, the EBO WWN organization also finalized its board composition with 7 board members, including a Chair, a Vice-President, a secretary and several board members each with an area to develop such as: structure of the organization, advocacy, white paper, communication, organization in regional clusters with regional coordinators, joint surveys, joint software, stakeholder discussion, best practices, financial sustainability, and stakeholder



# **Member Story - Interview of**



La Folie, a charming lodge located on Don Daeng. an island facing Champassak Town, opened its doors in 2007 and was striving, until 2019. Like many of our members from the hospitality sector, it went through consequent hardship for the last 3 years when the pandemic pushed the industry into meltdown. As a result of the pandemic, Laos PDR closed its door to tourists for 3 years. The economic fallout that resulted from this led to significant and financial stress for hotels. potentially impacting the long-term viability of many hospitality firms. Considering the financial stress, the hospitality sector (along with many others), was compelled to rethink, restructure, and rebrand and adapt to a new normal to ensure survival. But now that the country has reopened mid-2022, although with a looming fear of safety and health concerns and very constraining "new normal" procedures, the hospitality and tourism industry had to come back stronger than ever before. ECCIL EuroCham will be focus several interviews on major stakeholders of this sector in the next newsletter, to keep a finger on the pulse of this "rebirth" of the Laos hospitality industry. To start this serie, ECCIL EuroCham Executive Director visited our member La folie Lodge and sat down with Mr Alom Keosaysong, General manager a la Folie since 2007, to talk about his experience and share it with our members.



# Can you tell us a bit about the background of la Folie Lodge?

The hotel was founded in 2007 with foreign capital by a French lawyer, Mr. Antoine de Noailles, who fell in love with the island of Don Daeng, in Lao the "Red Island". The Island is peaceful and within the UNESCO protected area of the Vat Phu. At the time there were no electricity or any type of public infrastructure. People worked their machine in agriculture with generators. The hotel was the first to bring electricity to the Island (with a cable going above the Mekong). And the hotel's 26 wooden room with private terrace and panoramic view of the Mekong River, were all entirely built by the population of the Island. We also have a swimming pool, spa, restaurant, bicycles, tropical garden, petanque court, and many other infrastructures for our guests.

# How was business pre-covid? Where do your guests mostly come from?

Most of our clients come from Europe, and more particularly from France and only about 10% are American and Russian, and we don't get many guests from neighboring Asian countries. 2015-2016 were our best years yet, but when covid hit, we had to close the hotel for a shot period to readjust.

When covid hit, you faced mass cancellations when the country completely closed for 3 years and had to pay salaries even without any international guests. What was your strategy to survive the crisis covid brought to the hospitality sector?

We were able to adapt fast and reopened only 2 months later, targeting expats and local population, mostly coming from Vientiane, Paksé, Savannakhet, Luang Prabang. We brought influencers, had huge promotion for the locals, and advertised to the local population and we were lucky to not have closed during the 3 years, like it happened for some many other businesses in hospitality. We managed to survive by diversifying and proposing additional service to locals at low price such as barbecue on the beach, picnic on a boat, catering etc. and mostly we had to cut our price in half and basically had a 50% promotion during that whole time. Now that the country has reopened since last May 2022, our European clients are coming back since June. But we are still performing only at the 50% of what we were doing pre-covid.

### What do you think is to blame for that?

One thing to blame for example would be the price and scarcity of the flights to Laos. Our clients usually like to plan and book 6 months ahead which was not possible last year. So, we will continue to target local market, as proved with the special offer that La Folie have shared for ECCIL EuroCham Members only. Indeed, as long as the hotel is not 100% full, we need to continue to be flexible with our prices.





We, at ECCIL EuroCham Laos, are all about promoting responsible investment companies who cares and have strong corporate social responsibility. La folie is indeed very involved in the development of the Island. Can you tell us about your community project with the island population?

We are the first employer of the island, with about 50 staff, all coming from the Island. That's 100% of the hotel staff, except the General Manager. We provide training and English class for our staff. The villager lives mostly of agricultures and fishing and sell in Champassak. La Folie buys all its agricultural products from the locals. To help improving the life on the island, we manage a donation box at the hotel lobby.


